### COLO PIGGERY PROPOSAL

An Environmental Impact Statement (EIS) has been released for a proposed piggery on land fronting the Putty Road north of Colo Heights. The piggery is proposed on the property which straddles the track which leads to Parr Spur and towards The Island. The property is in the catchment of Angorowa Creek, a tributary of the Colo River.

The proposal would involve housing for approximately 2,000 pigs initially with expansion to twice that size at some future date. The EIS fails to adequately assess the potential impact of the proposal on the water quality of Angorowa Creek. No information is included on size of effluent dams or design standards. The piggery has the potential to cause serious pollution of Angorowa Creek.

Those wishing to oppose the proposal should write to the Hawkesbury Shire Council, George Street, Windsor, by 5th July, outlining their objections. Further information on the proposal can be obtained by reading the EIS at the Environment Centre, 399 Pitt Street, Sydney.

### OXLEY NATIONAL PARK

The Premier of NSW, The Hon Neville Wran, QC MP, has announced the NSW Government's firm commitment to the establishment of Oxley National Park in the Macleay-Apsley Gorge area.

"This spectacular gorge country has magnificent wilderness, scenic, recreation and conservation values." Mr Wran said. "My Government is firmly committed to the establishment of Oxley National Park to protect these values for this and future generations."

"Australia is one of the most urbanised countries in the world. We must protect some of our wild and scenic land to be wilderness for all time. The value cannot be measured in dollars and cents - it is for the spirit of our people."

Mr Wran said the proposed Oxley National Park would be vacant Crown land and existing national parks and nature reserves in the area which together totalled over 32,000 hectares.

Mr Wran said 15,000 hectares of vacant Crown land would be combined with the existing 3,456 hectare Yarrowitch Gorge National Park, the 6,718 hectare Apsley Gorge National Park, the 1,659 hectare Rowleys Creek Gulf Nature Reserve, and the 5,587 hectare Hole Creek Nature Reserve.

The Premier has indicated that the Government is not prepared to dam the Apsley or Macleay Rivers.

### CLOSURE OF BARRINGTON ROADS

The Director of the NSW National Parks and Wildlife Service, Mr John Whitehouse, has announced the temporary closure of all four-wheel drive trails in the Barrington Tops National Park from Saturday, June 1.

Mr Whitehouse said the annual winter closure was a protective measure for both the public and the trails.

"In winter weather conditions, these trails can become hazardous with use", he said.

"By closing them, we reduce the need for maintenance, which can be very expensive, and ensure that the trails remain safe.

We are asking members of the public to co-operate with park staff, as they have done in the past, by observing the closed period."

The trails will be re-opened, weather permitting, on October 1st.

Ed's Comment: It's about time the Service became serious about preventing the damage caused by use of the trails in Barrington. Erosion on the Lagoon Pinch-Carey's Park section is horrific. Bushwalkers should write to the Service suggesting the road closure becomes permanent.

#### DOCTORS' CONCERN ON GAS BURNS

Camping stove accidents are causing increasing concern to specialists in burn injuries who say the butane gas stoves involved are "intrinsically very hazardous."

At least three people died last year from burns after such accidents while camping in tents or caravans.

Research at the Wessex regional burns unit and the Odstock Hospital, Salisbury, has shown that of 31 victims of stove fires admitted to the hospitals in the past 10 years, most spent more than 10 days in hospital, and four needed skin grafts. One died.

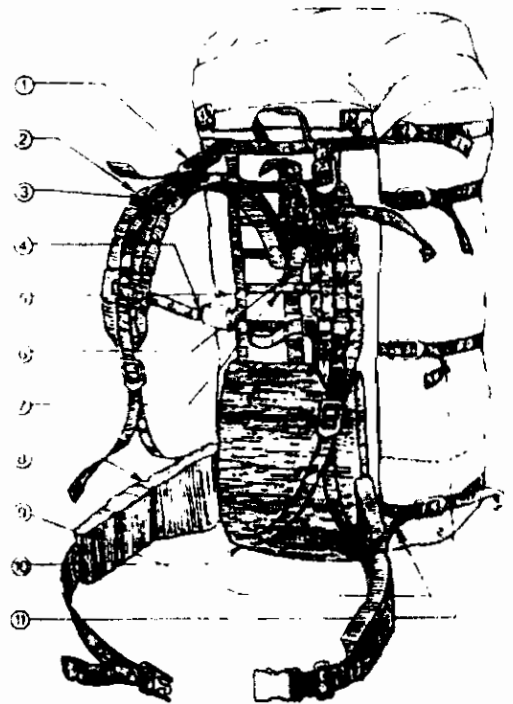

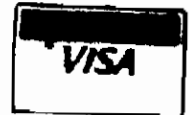

liquid butane. The gas is released to the burner after the canister has been pierced by a sharp point of the burner-valve unit.

If the burner-valve unit is not properly fixed into the appliance, gas will leak from the canister, and if there is a naked flame nearby will cause an explosion.

According to Dr Peter Shakespeare, of Odstock Hospital, at least 18 of the accidents he helped investigate happened while, or immediately after, the canister was being changed.

"Even when the appliance is changed in accordance with the instructions, pressurized and uncontrollable leakage of the butane gas occurs from the moment the canister is pierced until a tight seal is established by screwing home the canister holder", he and Mr Peter Saxby, a consultant surgeon, say in a report of their research. "Further leakage of the explosive gas is only prevented by a small sealing washer pressed onto the canister."

There were 18 deaths involving butane or propane gas during 1982-83, according to Department of Trade figures. They included seven explosives from heaters, three from cigarette lighter refill tubes, two from gas pokers and one from a camping stove.

Between November 1983 and February 1985, there were 76 non-fatal accidents involving gas or propane appliances.

A man who became a quadriplegic in an accident at a Sydney yacht club is suing more than 100 people who were members of the club at the time of the accident six years ago.

Hermanus Van Ryan, aged in his 50s, of Caringbah, fell while lowering a dinghy into the water from a jetty at the Vaucluse Yacht Club on March 29, 1979.

Mr Van Ryan, who was not a club member, broke his neck and became a quadriplegic, Master Greenwood said in the NSW Supreme Court yesterday.

At the time the club was not incorporated. It was only incorporated as the Vaucluse Yacht Club Ltd from January, 1981.

The statement of claim alleges that the club members were the occupiers of the premises and that Mr Van Ryan went to the premises at their invitation and with their permission.

Master Greenwood granted an application by Mr Van Ryan that certain club members be appointed as defendants to represent all those who were members at the relevant time.

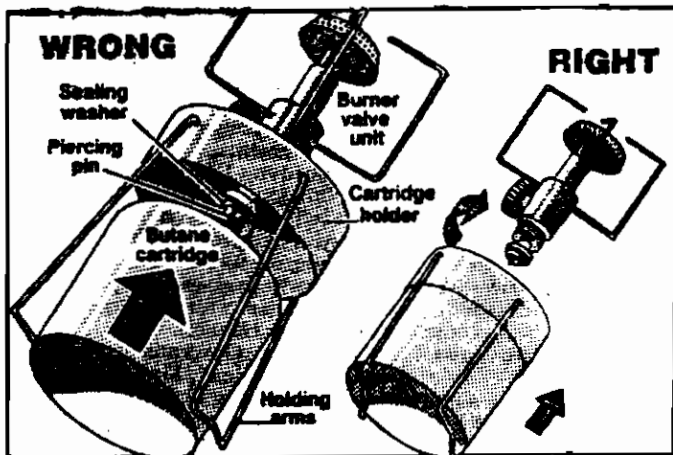
Master Greenwood named the representatives as Mr David G. Green, now the club's treasurer and Mr Douglas McBean Cameron, its vice-commandore. (AAP)

The Department of Trade has written to 20 burns units in England and Wales seeking details of other such accidents to help decide what action might be required.

Dr Chris Laurence, director of a Medical Research Council group at the Birmingham Accident Hospital, said: "Victims say it is a very frightening experience. They describe a slow, explosion in which they see a roll of flame coming towards them, but they cannot escape from it."

## ABOUT THE ORGANISATIONS

### THE ENVIRONMENT CENTRE OF NEW SOUTH WALES

The Centre was established in July, 1974 as a direct result of the Australian Government's Inquiry into the National Estate and is today an integral part of the conservation movement of this State. With a basic aim of the promotion of conservation in NSW it has a unique role as an apolitical, non-issue orientated community service centre. It provides information, resources and advice on a wide range of environmental and conservation matters.

The Centre receives a very large number of visitors each year and additionally handles a very high level of telephone and mail inquiries. As part of its information services it maintains a comprehensive reference library containing books, periodicals, Environment Impact Statements, Hansards and newspaper clippings.

The Environment Centre also provides a wide range of services and facilities for use by conservation organisations, ranging from the provision of office space and telephone answering to telex facilities, offset printing and meeting rooms. Many organisations who are today prominent members of the environment movement in this State received much assistance in their formative stages from the Environment Centre and links are still maintained.

### THE NATURE CONSERVATION COUNCIL OF NEW SOUTH WALES

The Nature Conservation Council is the umbrella body for the conservation movement in NSW. Its Annual Conference and elected Executive represents the major policy formulating mechanism for the conservation/environment movement in NSW and the Council pressures for the adoption of agreed policies by appropriate authorities. At present it has 78 Member Bodies representing a minimum of 140,000 individual members.

The Council and its Executive closely watch developments affecting the conservation of natural resources in the State, engage in research, and make submissions to government departments, committees and inquiries. By such actions, the Council's activities provide a significant opportunity for the community to make their views widely known.

The Nature Conservation Council is keenly concerned with such specific issues as wildlife protection, environmental education, habitat preservation, resource usage, pollution, land degradation and sound land-use planning.
